This letter forwards the current list of Orders of Interest to the Defense Nuclear Facilities Safety Board (Board) in the following enclosed tables:

- Table 1 Original List of 51 Orders of Interest to the Board,
- Table 2 Additions to Original List of 51 Orders of Interest to the Board Due to Expanded Board Jurisdiction to Include Weapons
  Dismantlement/Fabrication Facilities, and
- Table 3 Other Additions to Original List of Orders of Interest to the Board.

These tables identify only Orders. The Board is also interested in all the associated directives, such as Rules, Policies, Manuals, Guides, Standards, Handbooks, and other documents relevant to the identified Orders, since these documents clarify and expand upon the Orders proper. In addition, the Board is interested in specific directives system documents that are not necessarily associated with Department of Energy (DOE) Orders. An example is DOE-STD-3013, Criteria for Preparing and Packaging Plutonium Metals and Oxides for Long-Term Storage, which is a key element in DOE's Implementation Plan for Board Recommendation 94-1, providing vital requirements for the safe stabilization and storage of plutonium metal and oxide. However, this Technical Standard is not guidance for an Order and is, therefore, not in the Order hierarchy.

The old four-digit Orders provided in Tables 1 and 2 are still of interest to the Board, even though some of these Orders are intended by the DOE to be cancelled or superseded by the issuance of new three-digit Orders or Rules. The Board will continue to consider the old Orders of Interest until the current contracts wherein these Orders are still in force have been renegotiated, amended, or replaced by new contracts, resulting in appropriate incorporation of the new Orders.

Table 3 includes the new three-digit Orders of Interest to the Board that were identified through the Board's public meetings, ending in December 1996, as well as three additional Orders that have been identified through the Board's staff's ongoing reviews of directives system documents that are being coordinated through the Departmental Representative's Office. As the Department develops new or revised Orders and associated directives system documents, we expect to continue to receive these documents for review. Based on these reviews, appropriate additions will be made to the listing of Orders of Interest to the Board and these additions will be identified to DOE.
